### **CALL TO ORDER/ROLL CALL**

Mayor Antonio Lopez called the meeting to order (jointly with the Successor Agency) at 6:05 p.m.

### **APPROVAL OF AGENDA**

Councilmember Avila reported that he would like to add an item to the agenda regarding cosponsoring an Affordable Care Act Workshop.

Assistant City Attorney Padilla stated that this item was brought to the City's attention after the agenda was posted and requires immediate action.

Carolina Perez is glad to see that the City Council is working with the community.

Julio Anlau, Field Representative for LAUSD Board Member Ratliff, requested that the City (again) table this item for the future date.

There were no further public comments.

Motion by Councilmember Fajardo, seconded by Councilmember Avila, to table this item to an unspecified date to allow City staff to further discuss the matter with the LAUSD School Board and to re-agendize when a new proposal is in place. At that time, staff is to prepare a mailer (not to exceed \$500) for distribution to area residents notifying them of said meeting date/time.

### **NEW BUSINESS**

6) CONSIDERATION OF ADOPTION OF RESOLUTIONS APPROVING JOB SPECIFICATIONS FOR RECREATION LEADER III, AMENDING THE SALARY PLAN, AND AMENDING THE TABLE OF ORGANIZATION

Recreation and Community Services Operations Manager Ismael Aguila presented the staff report and replied to questions from Councilmembers.

Mayor Pro Tem Ballin expressed concern regarding part-time employees exceeding the maximum allowable hours (a very costly mistake).

Councilmember Gonzales also suggested keeping an eye on the probation period for the employees (some have passed probation that should not have).

Motion by Councilmember Gonzales, seconded by Mayor Pro Tem Ballin, to:

- a. Adopt Resolution No.7586 approving the job specifications for the position of Recreation Leader III;
- b. Adopt Resolution No. 7583 amending the Salary Plan to include a part-time Recreation Leader III position;

- c. Adopt Resolution No. 7584 amending the Table of Organization to include two parttime Recreation Leader III positions; and
- d. Authorize the Interim City Manager to initiate the recruitment process for part-time Recreation Leader III personnel.

By consensus, the motion carried.

7) CONSIDERATION OF FISCAL YEAR 2012-2013 CITY ANNUAL FINANCIAL REPORTS

Interim Finance Director Rafaela King presented the agenda report. Both she and Interim City Manager Ramirez responded to questions from Councilmembers.

Interim City Manager Ramirez talked about the mishandling of the issues in the past such as the Grant Fund and the absence of critical loan agreements (i.e., Senior Housing CHFA loan and the Swap Meet loan). He reported that there is a lot of work ahead, staff is looking at different options, and retiring the debt will require a multi-year solution.

By consensus, the following reports were received and filed:

- a. 2013 Comprehensive Annual Financial Report covering the financial activities of both the City and Successor Agency of the Former Redevelopment Agency; and,
- b. 2013 Cities Financial Transactions Report for the City of San Fernando.
- 8) CONSIDERATION OF CITY ANNUAL LOS ANGELES COUNTY METROPOLITAN TRANSIT AUTHORITY (LACMTA) AUDITED FINANCIAL REPORT

Interim Finance Director Rafaela King presented the agenda report.

9) CONSIDERATION TO AUTHORIZE SUBMITTAL OF APPLICATION TO THE CALIFORNIA DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT HOUSING RELATED PARKS PROGRAM GRANT TO FUND RECREATION PARK IMPROVEMENTS

Interim City Manager Ramirez presented the staff report.

Motion by Councilmember Gonzales, seconded by Councilmember Avila, to adopt Resolution No. 7585 authorizing the City's submittal of a grant application to the California Department of Housing and Community Development Housing Related Parks (HRP) Program in the amount of

\$176,550 to provide funds for park improvements at Recreation Park. By consensus, the motion carried.

### 11) AFFORDABLE CARE ACT WORKSHOP

Councilmember Avila reported that the offices of Congressmember Tony Cardenas and Assemblymember Raul Bocanegra requested to work with the City to offer residents information regarding available health care options.

Motion by Mayor Lopez, seconded by Mayor Pro Tem Ballin, that the City co-sponsor the event and allow the use of the Council Chambers and City seal for a workshop to be held on February 13, 2014. By consensus, the motion carried.

### **GENERAL COUNCIL COMMENTS**

Councilmember Avila thanked residents for coming out to the meeting.

Councilmember Gonzales thanked Public Works staff for their work and said that all employees continue to do a great job.

Councilmember Fajardo talked about the roll-out of the new City-wide refuse services (every house should be canvassed).

In response to Mayor Lopez' inquiry for an update on the new refuse company, Interim City Manager Ramirez reported that outreach has included community meeting advertisements in the local paper, two bi-lingual mailers to residents (per residential number), Spanish/English robocalls, a door-to-door campaign from the Republic Services team, and he stated that a service representative will be situated at City Hall to take payments and answer questions during regular business hours. He also stated that staff has attempted to reach out to Crown Disposal to facilitate the transition process but have been unsuccessful and that the City is also awaiting payments due from Crown.

Mayor Pro Tem Ballin reported that the Governor has declared a drought and she said that if San Fernando is required to purchase Metropolitan Water District water, the City will be shocked at the cost (there is an immediate need for San Fernando to come up with a plan).

Interim City Manager Ramirez reminded Councilmembers that although the regular meeting is adjourning, the special meeting would reconvene to continue the Closed Session items.

### **RECOMMENDATION:**

It is recommended that the City Council adopt a Resolution (Attachment "A") approving the Warrant Register.

### **BACKGROUND:**

For each City Council meeting the Finance Department prepares a Warrant Register for Council approval. The Register includes all recommended payments for the City. Checks, other than handwritten checks, generally are not released until after the Council approves the Register. The exceptions are for early releases to avoid penalties and interest, excessive delays and in all other circumstances favorable to the City to do so. Handwritten checks are those payments required to be issued between Council meetings such as insurance premiums and tax deposits. Staff reviews requests for expenditures for budgetary approval and then prepares a Warrant Register for Council approval and or ratification. Items such as payroll withholding tax deposits do not require budget approval.

The Deputy Finance Director hereby certifies that all requests for expenditures have been signed by the department head, or designee, receiving the merchandise or services thereby stating that the items or services have been received and that the resulting expenditure is appropriate. The Deputy Finance Director hereby certifies that each warrant has been reviewed for completeness and that sufficient funds are available for payment of the warrant register.

SUBJECT: Consideration to Approve the Mayor's Proposed Appointment to the City's

Vacant Position on the Oversight Board to the Successor Agency to the San

Fernando Redevelopment Agency

#### **RECOMMENDATION:**

It is recommended that the City Council approve the Mayor's appointment of Junior Accountant Sonia Gomez-Garcia to the Oversight Board to the Successor Agency to the San Fernando Redevelopment Agency fill the currently vacant position pursuant Health and Safety Code Section 34179(2).

#### **BACKGROUND:**

- 1. On April 2, 2012, the City Council approved the Mayor's appointment of Assistant Planner Edgar Arroyo and City Planner Fred Ramirez to the two City-allotted positions on the seven-member Oversight Board to the Successor Agency to the San Fernando Redevelopment Agency pursuant to Health and Safety Code Section 34179(a)(2) and 34179(7), respectively.
- 2. On February 11, 2014, Assistant Planner Edgar Arroyo formally submitted his resignation from the Oversight Board effective February 17, 2014. Edgar's resignation from the Board coincided with his acceptance of a new position with another municipality and resignation from employment with the City of San Fernando.
- 3. Pursuant to State Dissolution Law (Health and Safety Code Section 34179), each Successor Agency to a former Redevelopment Agency shall have an Oversight Board composed of seven members. The members must elect one of their members as the chairperson and shall report the name of the chairperson and other members to the Department of Finance on or before May 1, 2012. The Governor may appoint individuals to fill any Oversight Board member position that has not been filled by May 15, 2012, or any member position that remains vacant for more than 60 days.

Health and Safety Code Section 34179 provides that a majority of the total membership of the Oversight Board shall constitute a quorum for the transaction of business. A majority vote of the total membership of the Oversight Board is required for the Oversight Board to take action. The Oversight Board shall be deemed to be a local entity for purposes of the Ralph M. Brown Act, the California Public Records Act, and the Political Reform Act.

Pursuant to Health and Safety Code Section 34179, the Oversight Board may direct the staff of the Successor Agency to perform work in furtherance of the Oversight Board's duties and responsibilities under Part 1.85. The Successor Agency shall pay for all of the costs of meetings of the Oversight Board and may include such costs in its administrative budget. Oversight Board members shall serve without compensation or reimbursement for expenses. Oversight Board members shall have personal immunity from suit for their actions taken within the scope of their responsibilities as Oversight Board members.

#### **ANALYSIS:**

Health and Safety Code Section 34179(a)(2) and Section 24179(7) provides that two members of the Oversight Board are to be selected by the Mayor. One member does not need to meet any particular requirements. In the case of the City of San Fernando Oversight Board appointments, Assistant Planner Edgar Arroyo was proposed by the Mayor and subsequently approved by the City Council in this manner. The other member representing employees of the former Redevelopment Agency shall be appointed by the Mayor "from the recognized employee organization representing the largest number of former Redevelopment Agency employees employed by the Successor Agency at that time." In this particular instance, former City Planner/Community Development Director Fred Ramirez was appointed by the Mayor and approved by the City Council to fill this position.

Pursuant to Health and Safety Code Section 34180, certain actions of a Successor Agency shall first be approved by the Oversight Board. An example of an action that requires such approval is a request by the Successor Agency to enter into an agreement with the City to reimburse the City for expenses incurred on behalf of the Successor Agency and to approve payment of identified enforceable obligations through the Oversight Board's ongoing review and approval of the Recognized Obligation Payment Schedules (ROPS) for each six-month period that makes up each of the associated fiscal years.

Pursuant to Health and Safety Code Section 34181, the Oversight Board must direct the Successor Agency to take certain actions. For example, the Oversight Board must direct the Successor Agency to cease performance in connection with and terminate all existing agreement that do not qualify as enforceable obligations.

# Proposed Appointees' Biographical Information

Sonia Gomez-Garcia has worked for the City of San Fernando for the past 19 years, including the last nine years as the City's Junior Accountant. As the Junior Accountant, Mrs. Gomez-

Garcia has worked directly with finance and City administrative personnel to ensure proper tracking of City and former Agency budgets. Furthermore, Mrs. Gomez-Garcia continues to play a critical role in ensuring that the City and Successor Agency comply with all applicable reporting requirements mandated by the State as part of the Dissolution Law including assisting with the preparation of the ROPS every six months, completion of the Successor Agency's Due Diligence Reports, and most recently assisting City Administrative staff with the preparation of the Long Range Property Management Plan. Therefore, Mrs. Gomez-Garcia's work experience in the Finance Department and specifically with overseeing budget reporting for the Successor Agency and the former Redevelopment Agency, make her a very qualified individual to fill the City's vacant position to the Oversight Board to the Successor Agency.

#### **BUDGET IMPACT:**

None. There will be no fiscal impacts associated with the decisions outlined above.

#### **CONCLUSION:**

The appointment of Junior Accountant Sonia Gomez-Garcia to represent the Mayor's selection of a member at-large to the Oversight Board to the Successor Agency of the San Fernando Redevelopment Agency will help address the immediate need to fill the vacant position while allowing the City to have an additional voice on the seven-member Oversight Board.

Nominations for the office of Mayor and Mayor Pro Tempore may be made by any member of the Council. Each selection shall be by three or more affirmative votes. In the event that no person receives three or more votes in the selection process (for one or both offices), the selection process shall be repeated.

The Mayor and the Mayor Pro Tempore will serve a one-year term, with the term expiring in March 2015.
