STAFF COMMUNICATION

Deputy City Manager/Public Works Director Chris Marcarello discussed possible ways of involving residents in disaster preparedness. Mr. Marcarello has put together a list and asked Council for their feedback.

Chair Ballin recommended message boards with 2-3 lines and big font that give disaster preparedness information be out during City events.

Shiarron Baker (LAC-DPH) informed that Council that the Department of Public Health has a nurse that does disaster preparedness training. Joe Goss can contact them to schedule trainings or booths for events.

Joe Goss informed the Council that he is looking into dates in early April for table top exercise.

Captain Van Blarcom briefed the Council on smoke detector program.
