## **DEPARTMENT HEADS - COMMISSION UPDATES**

Recreation Supervisor Maribel Perez gave an update regarding the upcoming 5K Relay event.

Interim Community Development Director Jack Wong gave an update regarding the recent workshops on the San Fernando Corridors Specific Plan. The information from the workshops will be integrated into the final draft Transit Oriented Development Plan Amendment/Environmental Impact Report documents that will be considered by the Planning and Preservation Commission and City Council.

Management Analyst Kenneth Jones reported that the Transportation and Safety Commission will be meeting on Wednesday.

City Clerk Chávez reported that the County Board of Supervisors approved the City's request to move our election date beginning November 2018 and she said City voters will be receiving notification. Also, a recent bill signed by the Governor to move the June State Primary Election to March will not affect our SB 415 November election date.

### **GENERAL COUNCIL COMMENTS**

Councilmember Soto thanked staff and welcomed City Manager Meyerhoff and appreciates that he's been meeting with Councilmembers.

Councilmember Fajardo reported that he attended the protest regarding dialysis centers and he talked about League of California Cities event that he recently attended.

Councilmember Gonzales briefly talked about the recent world-wide disasters in Mexico, Houston, Puerto Rico, Las Vegas, and said his prayers go out to all of the victims and families. He thanked Mayor Ballin for adding the water presentations on today's agenda and that it was good to hear from both ends of the spectrum.

Vice Mayor Lopez also said that his prayers and thoughts go out to those affected by the recent multiple disasters.

Mayor Ballin agreed that there is much to consider regarding the California WaterFix situation. She also requested the use of City letterhead to send an appreciation letter to San Juan Mayor Carmen Cruz. By consensus, Council agreed.

Both Mayor Ballin and Councilmember Soto talked about possibly creating an Ad Hoc Committee to discuss raising funds (or the proper channels to generate money) for victims affected by these recent disasters.
