Project: STREET SWEEPING SERVICES

A. The following change to the **Request for Proposal** will apply to this project.

5. PROPOSAL FORMAT AND CONTENT

Proposals should be typed as briefly as possible. They should not include any elaborate or unnecessary promotional material. The following order and content of proposal sections should be adhered to by each contractor:

i. **Equipment**

Vehicles and equipment used in street sweeping services must be kept well-maintained and in good appearance. Vehicles and equipment used in accordance with sweeping activities should be not more than three (3) years old and must meet all applicable local, state, and federal air quality laws, rules, and regulations including but not limited to the South Coast Air Quality Management District Rule 1186 relating to alternative fueled sweeping equipment. Equipment shall meet all applicable certifications for PM 10 and other pollutants as set forth by the South Coast Air Quality Management District. The contractor shall identify the equipment including make, model, license number, and type of sweeping function utilized (regenerative air, side broom, rear broom, etc.) and indicate whether equipment is primary or back up unit. Contractor shall identify the equipment that will be used to meet these requirements and what are the maintenance levels and practices utilized to ensure equipment is maintained in good repair, appearance, and sanitary conditions at all times.

Equipment shall meet all applicable certifications for PM 10 and other pollutants as set forth by the South Coast Air Quality Management District. The contractor shall identify the equipment including make, model, license number, and type of sweeping function utilized (regenerative air, side broom, rear broom, etc.) and indicate whether equipment is primary or back up unit. Contractor shall identify the equipment that will be used to meet these requirements and what are the maintenance levels and practices utilized to ensure equipment is maintained in good repair, appearance, and sanitary conditions at all times.
