**Subject:** Unlicensed Driver Community Education Workshop Update

### **RECOMMENDATION:**

It is recommended that the Transportation and Safety Commission receive and file this report in regards to a community education workshop (to be provided virtually) to educate members of the community on how to take the necessary steps to apply for and obtain a driver's license.

### **BACKGROUND:**

- On October 7, 2020, Chair Mohr discussed her concern regarding unlicensed drivers in the City. Item was discussed during the Commission meeting and staff was directed to provide a link to the Department of Motor Vehicles (DMV) driver's license webpage on the City's website.
- 2. On November 4, 2020, staff updated the Commission on DMV information that was added to the City's webpage under the tab for *Residents* (scroll down to "How to apply for a driver's license"), which takes you to the following link on the DMV website: <a href="https://www.dmv.ca.gov/portal/driver-licenses-identification-cards/driver-licenses-dl/">https://www.dmv.ca.gov/portal/driver-licenses-identification-cards/driver-licenses-dl/</a>
- 3. On February 3, 2021, Chair Mohr recommended a virtual workshop to educate the community on how to obtain a driver's license. Since that time, Chair Mohr has worked with Sergeant Peter Aguirre on available resources.
- 4. On March 3, 2021, the Commission voted to move forward with the workshop for unlicensed drivers

### **ANALYSIS:**

Since the February 3, 2021 Commission meeting, Sergeant Aguirre and Commission Chair Nicole Mohr have discussed the option of hosting a community workshop to educate residents on how to obtain a driver's license.

### Community Workshop.

The virtual workshop would cover the following topics:

- The risks of driving without a license.
  - o Financial liability if involved in a collision.
  - Legal consequences for driving without a license.
- How to get a driver's license.
  - o Differing requirements for those under age 18.
  - Local resources for behind-the-wheel training.
  - o Online resources for test preparation.
  - o The logistical process of acquiring a license in this community.
- Driver's License availability for undocumented Californians.
- An informal Q&A about driver's license laws.

### <u>Traffic Safety Correlation to Unlicensed Drivers.</u>

The need for community education exists because:

- The San Fernando Police Department cites a high number of persons each year for driving without a license.
- Unlicensed drivers are statistically more likely to be involved in traffic collisions.
- Driving without a license is one of the most common reasons for drivers fleeing the scene of a traffic collision, which can be a misdemeanor or a felony, depending on the severity of the damage in the collision.

### Community Outreach.

The City will use its social media platforms to advertise the workshop using the promotional material provided (ATTACHMENT "A"). The promotional material includes the links to the Zoom workshop as well as a link to the City's YouTube page. The workshop is also mentioned in the City Manager's Monthly Report. The workshop will take place on Thursday, May 13 at 7 PM.

### **RECOMMENDATION:**

It is recommended that the Transportation and Safety Commission direct staff to conduct potential traffic studies at Intersections of South Huntington Street and Griffith Street, Fourth Street and Fermoore Street, and Fifth Street and Fermoore Street.

### **BACKGROUND:**

1. On April 7, 2021, the Transportation and Safety Commission received public comment seeking potential traffic control devices be installed at different locations within the City of San Fernando.

### **ANALYSIS:**

At the April 7, 2021 Transportation and Safety Commission Meeting, Staff received two (2) public comments expressing their concern about speeding vehicles at different locations within the City of San Fernando. The installation of traffic control/calming devices were requested as part of their public comments.

### Fourth Street and Fermoore Street

At the meeting of April 7, 2021, a public comment was provided requesting that a stop sign be installed at the intersection of Fourth Street and Fermoore Street. The resident stated that the intersection has a high traffic volume and that she has observed many incidents where vehicles fail to yield to pedestrians attempting to cross the street.

Staff has evaluated the location and it does meet the minimum criteria to qualify for the installation of a stop sign. Staff also considered the location of Fifth Street and Fermoore, as it meets the same minimum distance qualifications for installation of a stop sign.

### South Huntington Street and Griffith Street

A resident on the 600 Block of South Huntington Street, submitted a written comment and also called in to express his concern about speeding vehicles on South Huntington Street and Griffith Street. He is requesting the installation of flashing beacons to the existing stop signs at the intersection. During the call-in comment, he expressed his appreciation for the San Fernando Police Department patrolling and issuing traffic violation citations in the area, but would like to know what other options exist for traffic calming.

In the past, a traffic study was conducted on South Huntington Street for the possibility of installing speed humps between Hollister Street and Woodworth Street. It was concluded that the criteria set forth in the City of San Fernando's Traffic Calming Master Plan were not met.

### **BUDGET IMPACT:**

If directed by the Transportation and Safety Commission to perform traffic studies, staff will have the Traffic Engineer evaluate the locations. The fee for the Traffic Engineer to perform the study is \$275/hr. The average for this type of study would cost approximately \$3,000.

### **CONCLUSION:**

The Transportation and Safety Commission directed staff to bring these items back for discussion at its May meeting. Based on review of the intersections, it is recommended that the Transportation and Safety Commission direct staff to proceed with traffic studies along South Huntington Street and the intersections of Fourth Street and Fermoore Street, as well as Fifth Street and Fermoore Street.
