**Subject:** August 2022 Notable Police Department Activities

#### **RECOMMENDATION:**

It is recommended that the Transportation and Public Safety Commission receive and file this informational report.

#### **BACKGROUND:**

Each month at the City of San Fernando Transportation and Public Safety Commission meeting, the Police Department submits and provides the governing board a brief overview of the previous month's activities and noteworthy events.

#### **ANALYSIS:**

The San Fernando Police Department (SFPD) has recently heightened and further integrated its community profile in three major areas: Community Engagement, Notable Events/Proactive Enforcement, and Quality-of-Life Enhancement.

In the month of August, the San Fernando Police Department engaged in the following significant activities:

#### **Community Engagement:**

- 1. On Wednesday, August 10 and Saturday, August 13, 2022, the Police Department hosted its monthly Chat-With-The-Chief at Bodevi Wine and Expresso Bar and Recreation Park respectively.
- 2. On August 17, the Police Department hosted its monthly Neighborhood Watch meeting at City Hall. Twenty-eight members of the community along with Mayor Mary Mendoza and Councilmember Ballin attended the meeting.

- 3. On August 17, Police Department officials participated in collaborative discussions with City Administration and SF Swap Meet Vendors in Council Chambers. Vendors brought safety-related issues and other concerns to the meeting. A second meeting was agreed upon where Police Department personnel would cover basic safety protocols in a presentation for SF Swap Meet Management and Vendors. The meeting is scheduled for the second week in September.
- 4. On August 22, Chief Fabian Valdez and Lt. Rosenberg joined Police Reserve Officer and Police Explorer Advisor Fernando Miranda and the San Fernando Police Explorers at Dodger Stadium for the Dodger's Law Enforcement Appreciation Night event.
- 5. On August 22, the Police Department participated in a Homeless Outreach event held at Las Palmas Park hosted by LA County Board of Supervisor Sheila Kueh' and CA State Senate Majority Leader Emeritus Robert Hertzberg.
- 6. On August 24, the Police Department hosted its monthly Business Watch meeting at City Hall.
- 7. On August 27, the Police Department provided security at the Monthly Street Fair held in the San Fernando Mall.

#### **Notable Events/Proactive Enforcement:**

- 1. On Wednesday, August 3, SFPD officers conducted a traffic stop on a vehicle in the 1600 block of San Fernando Road for a vehicle code violation. Officers spoke with the driver and later arrested the driver for being in possession of burglary tools and no installation of an interlock device on the vehicle. The male passenger was also arrested for an unrelated parole warrant.
- 2. On Thursday, August 4, SFPD officers conducted a traffic stop on a vehicle at Hubbard Ave. and First Street. Officers spoke with the driver and learned that he was on active parole for carjacking. It was later discovered that the driver was in possession of narcotics for sales and burglary tools. The driver was arrested and charged.
- 3. On Thursday, August 8, SFPD officers responded to a call of shots fired in the 500 block of Jackman Avenue. During their investigation, officers learned that a resident had heard a loud metallic grinding noise coming from the outside of his home. The resident went outside to investigate where the noise was coming from and confronted a thief who was attempting to remove the catalytic converter from his vehicle. The thief fled the scene and jumped into a nearby getaway vehicle. As the vehicle drove away, the driver of the getaway vehicle fired one round at the resident. No one was injured during this incident and it is currently under investigation.
- 4. Early in the morning of Thursday, August 18, a large power outage occurred in the City of San Fernando, which was later determined to have been caused by an unknown suspect(s) who

was/were attempting to steal wiring from a nearby electrical box. Power was restored a few hours later.

- 5. On Friday, August 19, SFPD officers responded to the 1100 block of Griswold Ave. for reports of shots being fired in the area. When officers arrived on scene, they determined that a nearby resident had confronted at least three subjects writing gang graffiti on a nearby building. The subjects fled the scene and during their flight, fired at least one round at the resident. No one was injured in this incident and it is currently under investigation.
- 6. On Monday, August 22, SFPD officers were dispatched to the 1200 block of San Fernando Road regarding a male subject creating a disturbance in the area. Officers spoke with the male subject and recognized him as a person of interest in a recently drafted SFPD crime bulletin. The individual was placed under arrest and charged with felony vandalism.
- 7. National Night Out will occur this year on October 4, in the parking lot adjacent to the police station. Preparations for this event are being finalized. Attendees are encouraged to register on-line prior to the event.

#### **Quality of Life Enhancements:**

- 1. Beginning August 15, SFPD directed patrol resources to providing additional traffic enforcement at our local schools during morning and afternoon hours to augment the Los Angeles School Police Department's efforts as the new school year got under way.
- 2. On Thursday, August 25, the Police Department deployed a traffic unit to conduct directed traffic enforcement throughout the City.

#### **BUDGET IMPACT:**

There is no budget impact associated with receiving this informational report and providing comment to the City Council.

#### **CONCLUSION:**

It is recommended that the Transportation and Public Safety Commission receive and file this informational report.
