#### **ADMINISTRATIVE REPORTS**

2) Discussion and Selection of the December/January 2022 Student of the Month

Chair Mohr shared that there are no nominees for the month of November. Commission will discuss the January/February nominee at December's meeting. Commissioner Govea is looking to present student of the month award at the second meeting in January 2023.

3) Discussion Regarding the Principals' Brunch

Commissioner Robledo provided a letter that was used in the past. At this time, the commission revised the letter making any corrections. The 1<sup>st</sup> paragraph of the letter provided by Commissioner Robledo will be used. Chair Mohr added that she would like to send out the letter and the save the date within the week. #### 4) Discussion Regarding Student Scholarship Program

Vice Chair Zobel-Rodriguez gave a brief update on a meeting held on November 28<sup>th</sup> with Finance Director Erica Melton. Mrs. Calleros will make sure scholarship checks have been cashed. Mrs. Calleros will also touch base with Vice Mayor Pacheco before December 5<sup>th</sup> to make sure his donation is secured for Future Filmmakers.

Director Venegas provided updated account balance reports. There are currently no debits or credits for the year. The commission is waiting for checks from Republic and Jerry's Kids. All scholarship donations will go through Mrs. Calleros and deposited in the current scholarship account. Scholarship program ending balance is \$4,235.

At this time, the commission revised the digital donation form flier making any necessary corrections. The revised version will be sent out in January 2023.

# 5) Discussion Regarding O'Melveny Elementary School's 100<sup>th</sup> Anniversary

Chair Mohr informed the commission that she has made contact with O'Melveny's principal. She is currently waiting on the principal to come back from medical leave for wording. The requested date per the principal's request is December 19<sup>th</sup>. Director Venegas informed Chair Mohr that there is no 2<sup>nd</sup> council meeting in December.

Director Venegas informed the commission that 1 revenue account has been set up for scholarships as well as an expenditure account. Each scholarship will be budgeted prior to the start of the new budget cycle beginning February 2023 and ending June 2023.

7) Discussion Regarding the Teacher Spotlight Program

Chair Mohr presented the teacher spotlight URL and QR code. The commission reviewed the spotlight nomination form and will continue to address as needed.

#### **GENERAL COMMISSIONER COMMENTS**

Chair Mohr suggested that the commission hold a special meeting in January. Details will be discussed during December's meeting.

Commissioner Govea shared that he and Commissioner Rodriguez met with Mayor Mary Mendoza and Councilmember Sylvia Ballin regarding possible secured scholarship funds. Details are still being worked out and he will provide updates as they come.

#### **STAFF COMMUNICATION**

Executive Assistant Calleros will continue to provide updates on student of the month gift card distributions. She also shared that Rec. Park and Las Palmas Park will be accepting canned food donations as well as pet toys and blankets. Free karate, total body conditioning, mixed line dance, and inclusive Zumba classes are being offered to the community in December.

Mrs. Hernandez shared that winter day camp registrations are now open. Camp runs from December 19<sup>th</sup> to January 6<sup>th</sup> 7:30am-5:30pm. Camp is open to kids ages 5-13.

Community Services Supervisor Salas shared that Las Palmas will be offering a technology and education workshop to teach parents how to navigate email, Zoom, and other school based apps. The first cohort will begin tentatively in January 2023. He also shared information regarding the tree lighting that is scheduled for Saturday, December 3<sup>rd</sup>. There will be music, art, Santa's workshop, etc. There will be no TBC canned food drive due to staff shortage.

Director Venegas provided updates on the city renovation projects. Layne Park hired a construction firm and expect to start the later part of December or early January. Las Palmas Park selected a firm to create a design. The firm will also conduct community outreach. They will also host various community meeting beginning mid-January.

The Annual Student Scholarship Program was established to assist San Fernando youth who are seeking a postsecondary education.

The scholarship program has grown from two scholarships to eight scholarships awarded annually. Scholarships are funded through donations from various donor sources, including, but not limited to current/former Councilmembers, organizations such as Independent Cities Finance Authority (ICFA), and Republic Services.

At the August meeting the Commission set an amount for each of the Student Scholarships that will be awarded in 2022-2023. They also reviewed the existing scholarship accounts and recommended all accounts be consolidated into one account.

#### **BUDGET IMPACT:**

There is no fiscal impact with the discussion of this item. Future expenditures are to be determined based on the Education Commissions' direction.
