LAUSD will be hosting a community event partnering up with the regional center on April 27th, 6pm-8pm. This event will be providing resources for students

to help them plan out what comes after high school. LAUSD is also working with Facilities Department on cool green spaces for schools in the valley. Maria will share all links and fliers along with summer school updates with the commission.

ADMINISTRATIVE REPORTS

2) Discussion and Selection of the May 2023 Student of the Month

Commissioner Govea announced the winners for the final student of the month. May's theme is Academic Achievements. The awardees are as follows:

- Fabian P., is a 5th grader at O'Melveny Elementary. He is kind hearted, motivated, and goes above and beyond. His perseverance has shown that hard work and dedication pays off.
- Fatima A., is a 9th grader at CCLA Social Justice Humanitas. She is an exceptional student. She is currently enrolled in 7 classes in addition to the community college classes she attends after school. Fatima is constantly seeking a challenge and inspires her teacher to look for more opportunities to help students grow.

Commissioner Govea motioned to accept both students as the May nominees. Motion seconded by Vice Chair Zobel-Rodriguez. By consensus, the motion carried.

Mr. Venegas informed the commission that both students will be recognized at the May 15th city council meeting. He also requested student bios be sent to staff.

3) Discussion Regarding Student Scholarship Program

Scholarship ceremony AD HOC and support staff provided updates on ceremony planning. Mrs. Calleros sent certified letters to all scholarship winners along with follow-up emails. She has received 3 responses and will send out another follow-up email to students and principals. Chair Mohr shared that she would like to invite the Daily News and the San Fernando Sun newspaper. Chair Mohr requested that ceremony photos be featured in the city's manager report along with a blurb if no press comes to the ceremony.

Commissioner Govea updated the Commission on ceremony planning. He discussed color scheme, decorations, and menu. There will be an adjustment made to the ceremony program listing the Gabriel Fernandez scholarship first. He also spoke about the order of special guest speeches. Ceremony AD HOC will be meeting again in the next week or two to continue planning.

4) Discussion Regarding the Graduate Recognition Program

Mr. Salas provided the Commission with 2 drafts. He is working with the husband of Vice Chair Zobel-Rodriguez on designs. Mr. Salas shared updates on colors, school logos and all other banner changes. He currently has 5 completed applications and 15 inquiries. Application deadline is this week. At this time he does not have a map of banner placement. He will share map information when available. Mr. Salas is currently working on the veteran recognition program. Chair Mohr suggested that the veterans program run from Veteran's Day to Memorial Day in 2024.

5) Discussion Regarding the Teacher's Spotlight Program

Vice Chair Zobel-Rodriguez presented the 2 nominees that will be honored in either May or June. The 1st nominee is Katheryne Pena from CCLA-Technology Prep Academy. The 2nd nominee is Ashley Ruiz from Nueva Esperanza Charter Academy. At this time the commission discussed when to recognize nominees and in what order. Mr. Venegas informed the commission that there are currently 4-5 presentations scheduled for the May City Council meeting. Mr. Venegas presented other possible City Council meeting dates. Commissioner Govea recommended that both nominees be recognized at the June 5th meeting.

Chair Mohr motioned that both be honored during the summer based on availability. Vice chair Zobel-Rodriguez seconded the motion. By consensus, the motion carried.

GENERAL COMMISSIONER COMMENTS

Commissioner Govea thanked the Recreation and Community Services Department staff for their support.

Chair Mohr shared that the Gay, Lesbian, Straight Education Network LA Chapter is hosting a free prom this upcoming Saturday for those who cannot afford to attend their own prom. This is also open to those who feel they cannot wear what suits their identity or partners. She also shared that she attended the outdoor night market which was well attended. She would like to agendize a brief discussion on the principal's non-alcoholic happy hour for next month's meeting.

At this time Mr. Venegas informed Chair Mohr of the new process for agendizing items. A commissioner presents the item, a discussion is held, and a vote is taken. City council is currently working on a guide and will be released when completed. Mrs. Calleros added that future agenda items require a month's notice. At this time, Chair Mohr motioned to discuss in May, a fall principal's event. Commissioner Rodriguez seconded the motion to approve the agenda item. She also made a second motion to agendize adding future agenda items to the list of items. Commissioner Govea seconded the motion. By consensus, the motion carried for both items.

STAFF COMMUNICATION

RCS Executive Assistant, Maria Calleros, announced the Vet in the Park event that will be held on Sunday, May 7th from 9am-1pm at Rudy Ortega Jr. Park. There will be free vaccines, veterinary examinations, microchips, flea medication, pet food, and deworming. Anyone interested can scan the QR code on the flier to schedule an appointment. Cyndy's Mixed Line Dance classes are back in session. Classes are held every Thursday at 10am at Recreation Park. On Saturday, May 27th, Las Palmas will be hosting a free stroke health fair provided by Providence Holy Cross from 8am-12pm. Registration for summer day camp and youth summer basketball league is currently open.

Community Services Supervisor, Juan Salas, added that the camp runs from June 20th through August 11th. San Fernando residents who qualify for the resident scholarship can apply the 50% discount to camp registration fee. Mr. Salas shared information on the Senior Expo taking place on May 19th at Las Palmas Park. There will be free food, entertainment, music, and a dance party following the expo. The American Legion Post 176 will be hosting a Memorial Day ceremony on Monday, May 29th at 1pm. Lunch and music will be provided along with special guest speakers. Senator Caroline Menjivar, who is also a veteran, will be in attendance. Movies in the park begin in July along with concerts in the park returning this summer. Mr. Salas will share information and fliers when available. Technology workshops will resume in May and will be targeting charter schools. Mr. Salas will also share that flier with the commission when available.

1) Discussion Regarding Student Scholarship Program

Commissioners discussed the scholarship ceremony and shared what went well, what needs work, and next steps.

All commissioners thanked support staff for their work and enjoyed all speakers and expressed appreciation to City Council. Chair Mohr spoke about the scholarship essay expectation structure. She also added that Mayor Celeste Rodriguez requested a group photo that showcases the community's impact.

Commissioners shared what needed work. Commissioner Rodriguez suggested making a special effort to include San Fernando and Sylmar High School along with on campus outreach. Commissioner Robledo suggested doing some outreach at local high school college centers. Vice Chair Zobel-Rodriguez read a statement on behalf of Commissioner Govea regarding his thoughts on what needs improvement. He suggested earlier access to Rudy Ortega Jr. Park, use the media more effectively, and making sure the park is maintained prior to the event. Vice Chair Zobel-Rodriguez suggested that the ceremony programs be proof read. She also said that she would like to see the scholarship event announced in the city's manager report. She also shared with Commissioners that in the last 8 years, a total of \$57,000 of scholarship money has been awarded to students.

Chair Mohr would like to have translation services available. She also requested that the scholarship financial spreadsheet be updated. Mr. Venegas will provide that update at next months meeting and informed the Commission that all checks have a 6 month grace period. After 6 months, the city starts reaching out to winners. Chair Mohr would like to reach out to college counselors in September inviting them to the October commission meeting. She added that she would like to plan a mixer inviting principals and college counselors. Commissioners

In accordance with Section 2-615 Officers... the members of the education commission shall annually in June elect one of its numbers as chair and one of its numbers as vice-chair, each to serve for a one-year term or until a successor is elected.

In accordance with Section 2-616 Meetings... the members of the education commission shall meet at least once a quarter at such time and place as it may fix by resolution.

BUDGET IMPACT:

The reorganization of the Education Commission will not impact the Fiscal Year 2023-2024 budget.

CONCLUSION:

It is recommended that the Education Commission proceeds with the annual reorganization for the selection of Chair and Vice Chair, discuss the time and date of the Education Commission, meeting, and propose any changes to the fixed schedule.

DIVISION 8. - EDUCATION COMMISSION

Sec. 2-615. - Officers; compensation.

- (a) The members of the education commission shall annually in June elect one of its number as chair and one of its number as vice-chair, each to serve for a one-year term or until a successor is elected. The city clerk shall serve as secretary to the education commission. In the absence of the chair, the vice-chair, and/or the secretary, any other member shall call the meeting to order, whereupon a chair and/or a secretary shall be elected from the members present to preside for that meeting.
- (b) The city council shall fix the amount of compensation, if any, to be paid to the members of the education commission.

(Ord. No. 1605, § 1, 5-16-2011)

Sec. 2-616. - Meetings; quorum.

- (a) The members of the education commission shall meet at least once a quarter at such time and place as it may fix by resolution. Special meetings may be called at any time by the chair of the commission or four members thereof by written notice served upon each member of the commission at least 48 hours before the time for the proposed meeting. Proper posting and Brown Act procedures will be followed.
- (b) Three members of the education commission shall constitute a quorum for the transaction of business, but a lesser number may adjourn from time to time for want of a quorum until a quorum can be obtained.

RECOMMENDATION:

It is recommended that the Education Commission:

a. Continue to discuss the Student Scholarship Program.

BACKGROUND/ANALYSIS:

The Annual Student Scholarship Program was established to assist San Fernando youth who are seeking a postsecondary education.

The scholarship program has grown from two scholarships to eight scholarships awarded annually. Scholarships are funded through donations from various donor sources, including, but not limited to current/former Councilmembers, organizations such as Independent Cities Finance Authority (ICFA), and Republic Services.

At the August meeting the Commission set an amount for each of the student scholarships to be awarded in 2022-2023. At the March meeting the Commission unanimously decided on the 2023 scholarship recipients. At the same meeting the date of May 23rd was set for the Annual Awards Ceremony with Commissioners Govea and L. Rodriguez serving on the event planning AD HOC.

BUDGET IMPACT:

There is no fiscal impact with the discussion of this item. Future expenditures are to be determined based on the Education Commissions' direction.

CONCLUSION:

It is recommended that the Education Commission continue the discussion regarding the scholarship program.
