## **POSITIONS FOR ELECTION**

There is one seat for an unscheduled vacancy to elect one Councilmember of the five-member City Council to fill a partial term for the balance of an unexpired four year term, and would expire in November 2024. The seat is presently unoccupied due to the passing of Councilmember Cindy Montañez.

### **CANDIDATE QUALIFICATIONS**

Must be 18 years of age, a citizen of the United States, and a registered voter residing within the City of San Fernando at the time nomination papers are issued.

## **NOMINATION PERIOD**

The Candidate filing period for nominations begins on November 13, 2023 at 7:30 a.m. and lasts through Friday, December 8, 2023 at 5:00 p.m. The City's normal hours of operation are Monday – Thursday from 7:30 a.m. to 5:30 p.m. and Fridays from 8:00 p.m. to 5:00 p.m.

#### NOMINATION PAPERS AND CANDIDATES HANDBOOKS

All candidates are requested to make an appointment during regular business hours to obtain and return nomination papers by calling the City Clerk Department at (818) 898-1204. Candidate Handbooks will be available on the first day of the opening of the nomination period, Monday, November 13, 2023. Obtaining nomination papers will take approximately 45 minutes.

#### **CANDIDATE STATEMENTS**

Candidates that choose to have a candidate statement printed on the County's sample ballot must pay for the printing of that statement, **estimated at \$650**, and is due when you return nomination papers.
