	If the results are certified by the RR/CC on November 29, 2024, the City Council may adopt a resolution reciting the results of the election and install newly elected Councilmembers.
December 2, 2024	Elections Code § 10263 - When a City election is consolidated with a statewide election, a newly elected official is to be installed in office no later than the next regularly scheduled City Council meeting after a certified statement of the results of the election is submitted by the county elections official to the city council, or at a special meeting called for this purpose.
December 3, 2024	The County of Los Angeles Board of Supervisors is tentatively scheduled to declare the November 5, 2024 Election, officially concluded.
