- **5. PROGRAMS AND ACTIVITIES AT SAN FERNANDO FAMILY CENTER AT PUIG'S HOUSE** J. Salcedo commented on agreement that was entered by The Wildhorse Foundation and the City of San Fernando to provide various services to the community. The agreement was to create a community center to provide services such as food, education and social services. The MOU was executed in April of 2019 with an investment of \$125,000. At the April 2024 Council meeting, Council agreed that the City would collaborate to seek grants to enhance and create more programming. Also, the City will provide support from the Recreation and Community Services Department for the use of facilities. The facility needs finishing touches in order to begin programs at the Puig House.

Commissioner J. Cuellar had questions regarding the Puig House modifications for disabled individuals and asked if there is a current Ad Hoc committee. She had questions regarding what has been done for the past 2 years as far outreach, funding and grants for improvements. She also inquired about the pledge of funds made by the foundation and the status of the various improvements that were discussed prior to the pandemic.

Chair R. Gonzales discussed a meeting that was held with Mission Community Hospital to partner with the City to offer cooking classes and hiring more Rec staff to offer additional programming.

**6. DEPARTMENT PROGRAMS AND SERVICES UPDATE** – Staff provided a report and presentation to receive and file on the programs, activities and events. All information on programming and activities is available on the City website.

Fernando Park Opportunity Plan (LOSIS/SF POP) Report from Kounkuey Design

Initiatives, Inc. (KDI).

#### **RECOMMENDATION:**

It is recommended that the Parks, Wellness and Recreation Commission:

a. Receive and File the Land and Open Space Inventory Study Report/San Fernando Park Opportunity Plan from KDI; and

b. Provide staff direction as appropriate.

#### **BACKGROUND:**

- 1. On February 5, 2018, the City Council adopted the Park and Recreation Master Plan (PMP) as an instrument for developing a comprehensive vision for park facility improvements and recreational programs offered to the residents of San Fernando. The PMP identified a lack of recreational facilities such as bike paths, walking trails and dog parks, but also recognized the scarcity of available land to build new park facilities.
- 2. On June 21, 2022, the City Council amended the Fiscal Year 2022-2023 budget to appropriate \$50,000 of American Rescue Plan Act (ARPA) funds for a Feasibility Study to identify New City Park Space.
- 3. On July 5, 2022, the City Council requested that staff look into the possibility of developing a dog park in the city.
- 4. On July 14, 2022, Los Angeles County RPOSD announced a \$185,000 allocation in TAP Services for the City of San Fernando. The funds are earmarked to assist in the development of new park facilities. Subsequently the City entered into a Master Agreement with RPOSD guaranteeing such funds.

- 5. On August 15, 2022, staff presented a concept for a Dog Park at San Fernando Recreation Park that could be funded with RPOSD annual allocation funds. While open to the idea, the City Council directed staff to take a broader approach for developing new park facilities. That approach would take the form of updating the PMP by conducting a land and open space inventory to define potential land for new park facilities.
- 6. On March 6, 2023, the City Council adopted Resolution No. 8220 allocating the \$185,000 Regional Parks and Open Space TAP Grant towards the study and authorized staff to circulate a Notice Inviting Bids.
- 7. On August 7, 2023, City Council awarded a Professional Services Agreement to Kounkuey Design Initiatives, Inc. to conduct a land and open space inventory study.

#### **ANALYSIS:**

The City of San Fernando is committed to fostering a sustainable and vibrant community through the effective management and preservation of its land and open spaces. As the city continues to grow and develop, it is essential to maintain a comprehensive understanding of the available land resources to ensure that future generations can enjoy a balanced and well-planned community.

The Land and Open Space Inventory report, also known as the San Fernando Park Opportunity Plan (SF POP), serves as a critical tool in this endeavor. It's aimed at enhancing the park system of San Fernando through identifying opportunities for the strategic development of new parks and recreation spaces. It provides an assessment of the city's current land use, highlighting areas designated for residential, commercial, industrial, and recreational purposes as well as expanding the scope to include development consideration of open spaces on public school properties and churches. The report also identifies existing open spaces including parks, underused parcels, tree canopy coverage, and transit lines that contribute to the resident's quality of life.

The information contained in the report is the result of a thorough and collaborative community engagement effort which included a community survey, event pop-up engagements, interviews with key stakeholders, meetings with special interest focus groups and local agencies as well as conceptual design workshops. Incorporating input from various user groups and community members reflects the city's commitment to transparency, sustainability, and long-term planning. As we look to the future, this Land and Open Space Inventory will be a vital reference in updating the Park and Recreation Master Plan (2018), as well as guiding the responsible and thoughtful development of green and recreational spaces in the City of San Fernando.

The total funding available for conducting the Land and Open Space Invenroty was \$235,000. The City Council allocated \$50,000 of ARPA funds and the Los Angeles County Regional Parks and Open Space District allocated \$185,000 from TAP Services. There is no budget impact to receive and file the Land and Open Space Inventory Study- San Fernando Park Opportunity Plan report.

#### **BACKGROUND:**

- The mission of the Recreation and Community Services Department (RCS) is to develop and implement enriching community, cultural, and recreational opportunities that foster the overall well-being and personal development of our community.
- 2. The RCS Department conducts a wide array of programs, services, activities, and business throughout the year. Staff provides a monthly update on items discussed at the Parks, Wellness, and Recreation Commission (PWRC) meetings and welcomes any guidance or recommendations regarding the items presented.

#### **DEPARTMENT UPDATES:**

#### **Programs and Services**

The RCS Department provides a variety of programming and services for the San Fernando community. All Los Angeles County Department of Public Health protocols and Best Practices guidelines for operating recreational facilities are strictly adhered to. Safety is the top priority for RCS staff when conducting activities for the community. All program participants and park

visitors are made aware of safety guidelines being implemented to ensure patrons feel safe while participating in the Department's programs.

#### City of San Fernando 113<sup>th</sup> Birthday Celebration

On Saturday, August 31, 2024, the City of San Fernando celebrated its 113th Birthday. The celebration drew in a large crowd to this annual event. With the outstanding voice of the master of ceremonies, Javier Verdin, guests enjoyed great entertainment, courtesy of the Mariachi Master Apprentice Program, Las Palmas Park Folklórico dancers, and an amazing performance by Sazón Tumbao. The Lopez Adobe hosted free guided tours of this 1880's historic landmark, owned by one of the earliest California families in the region. The festivities offered good food, great entertainment, sweet treats, and also the participation of special dignitaries recognizing this special day in the City's history.

#### **Cooling Centers**

Heat can become dangerous, especially for seniors, children, pets, people who work outside, and those with certain health conditions. The City of San Fernando provides relief from extreme heat by activating cooling centers at Recreation Park located at 208 Park Avenue and Las Palmas Park located at 505 South Huntington Street. Cooling Center hours are 9:00 am to 7:00 pm. For more information call (818) 898-1290.

Simple tips to staying cool

- Drink plenty of cool water! Stay hydrated.
- Wear loose, light-colored clothing that will keep you cool. Wear sunscreen and a hat for protection.
- Check on neighbors who might be vulnerable to the heat, especially those without air conditioning.
- Never leave children or pets in a car not even for one minute. Temperatures inside a car can quickly skyrocket to deadly levels.
- Never walk your dog on a hot surface (pavement, asphalt, etc.) If you
  can't walk barefoot on these surfaces comfortably, your dog feels the same way!
- If you work or play outside, take frequent breaks to hydrate and cool off in the shade.
- Don't forget the pets! Keep pets indoors if possible. If kept outside, give them plenty of water and shade to rest in. Never walk your dog on hot pavement. If it's too hot for your bare feet, it's too hot for your dog's paws.
- Symptoms of heat-related illness include dizziness, fatigue, faintness, headaches, muscle cramps, and increased thirst. If you experience these symptoms, seek medical attention.
